## **CONSTRUCTION UPDATE** Your Assistance is Urgently Needed!

With the exception of the landscaping and top course of asphalt roadway paving, the exterior work is substantially completed and 100% watertight. This includes all the roofing, stucco, brick, windows, storefronts, doors, emergency generator, rooftop units, sidewalks, pavers, railings, terrace dividers, courtyards, mosaic, and the annex building work.

On the interior, the elevator, MEP (mechanical, electrical, plumbing) rough-in, and framing work is substantially completed. All of the sheet rock for the project is stored on-site, awaiting installation, as the necessary funds are made available. Once the construction loan is accessed, work can be accelerated, and the project completed in 6-8 months. Overall, the project is 70% complete.

We are most appreciative to those who during the last 2 months or so have responded to the critical need by participating in the Capital Campaign. Their generosity enables the work to continue, but the harsh reality remains that unless we receive additional funding, we will be left no option but to TEMPORARILY suspend construction. If you have not already participated in the Campaign or if you have already made a donation and want to make another, **NOW** is the time for you to act. Suspending construction will not only result in increased costs to restart the work, but more importantly, will delay the opening of the new facility which is critical to serve the increasing needs of the elderly community.

If it wasn't for historic inflation which added over \$7,000,000 to the cost of the project, the construction loan (which is only available to complete the last \$10m of costs) would have been accessed and the new facility would be operating by now. With your help we can close the funding gap, access the loan and finish the project! 
